AN ORDINANCE DECLARING CERTAIN TERRITORY ABUTTING THE VILLAGE OF UNDERWOOD, MINNESOTA, TO BE AN ADDITION TO SUCH VILLAGE OF UNDERWOOD, MINNESOTA, AND KNOWN AS MOEN'S ADDITION TO UNDERWOOD, MINNESOTA.

The Village Council of the Village of Underwood, Minnesota, do ordain as follows:

SECTION I.

That WHEREAS the petition of Christian J. Moen, owner of the real estate hereinafter described, has duly filed herein his petition asking to have such property annexed to the Village of Underwood, Minnesota, and to have same declared as an addition to such village, and

WHEREAS such property hereinafter described has been platted into out lots and abuts upon the incorporated Village of Underwood, Minnesota, which is a village of less than ten thousand inhabitants, and

WHEREAS the village council deems it expedient and for the best interests of such village that such property be so annexed to such village and to be declared to become an addition thereto,

NOW THEREFORE the following described real estate, which is real estate abutting upon the Village of Underwood, Minnesota, and the real estate described in such petition, to-wit:

Beginning at a point where the right of way of the Northern Pacific Railroad intersects the east line of Government Lot ten (10) of Section thirty-two (32), Township one hundred thirty-three (133) north, Range forty-one (41) west of the fifth Principal Meridian, thence north four hundred eighty-one and four tenths feet (481.4) to the shore of Bass Lake, thence north eighty-seven (87) degrees west along the shore of said lake two hundred eighty-two (282) feet, thence north sixty-three (63) degrees west five hundred seventy-seven (577) feet, thence south six hundred twelve (612) feet to said railroad right of way; thence in a southeasterly direction along said railroad right of way eight hundred eighteen and eight tenths (818.8) feet to the place of beginning, and containing nine and eighty hundredths (9.80) acres,

Is hereby declared to be an addition to the Village of Underwood, Minnesota to be known as "Moen's Addition to Underwood, Minnesota".

SECTION II.

That from and after the passage and publication of this ordinance, the territory above described shall become a part of such Village of Underwood, Minnesota, as effectually as if same had been originally a part thereof.

SECTION III.

That this ordinance shall take effect immediately upon its passage and publication.
